#### **ROCK SALT CONTRACT AWARD**

**WHEREAS**, pursuant to the Lead Agency of the Atlantic County Cooperative, advertising for sealed bids to be publicly opened and read aloud for furnishing and delivering Rock Salt was received in June 14, 2019

**WHEREAS**, the winning bid was submitted by Mid-Atlantic Salt, LLC, New Castle, PA 16001 at a price of \$56.88 per ton.

**WHEREAS,** participating members of the Cooperative must award and execute a new contract with the winning bidders;

**NOW THEREFORE BE IT RESOLVED,** by the governing body of the Borough of Folsom that a contract for Rock Salt is awarded to Mid-Atlantic Salt, LLC for Rock Salt at a price of \$56.88 per ton. The term of the contract shall be for a period commencing September 1, 2019 and terminating May 31, 2020.

**BE IT FURTHER RESOLVED,** that the Mayor and Borough Clerk are hereby authorized to enter into a contract with Mid-Atlantic Salt, LLC and sign the necessary agreements as representatives of Borough of Folsom.

# RESOLUTION EXCLUDING PUBLIC PARTICIPATION WITHIN A PORTION OF A MEETING OF THE BOROUGH COUNCIL PURSUANT TO N.J.S.A. 10:4-12

**WHEREAS**, meetings of the Mayor and Borough Council are subject to the provisions of a Statute entitled the "Open Public Meetings Act" codified within N.J.S.A. 10:4-12, et. seq.;

WHEREAS, the said Act provides for public participation within all meetings, except those meetings or business which involve certain enumerated activities of a public body as further set forth in the said Statute; and

**WHEREAS**, the Borough Council desires to discuss and act upon matters subject to the exclusions of said Act under the provisions of N.J.S.A. 10-4-12, et seq.; and

WHEREAS, the Act hereinabove recited provides that a public body may exclude public participation within any meeting wherein such matters may be discussed or acted upon provided that a Resolution be adopted at a meeting to which the public is admitted;

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Folsom, as follows:

A. The public shall and will be excluded from that portion of a meeting conducted by the Borough Council on Tuesday, September 10, 2019, pertaining to matters contemplated in N.J.S.A. 10:4-12 et seq., and to specifically include a matter under N.J.S.A.10:4-12(7) (8) possible litigation and a personnel matter.

#### **Action Items:**

# NJDOT FY2019 Municipal Aid Project:

The plans and specifications for the 2019 Road Program - Resurfacing of Backline Road have been forwarded to the NJDOT for review and approval. The project begins on Backline Road, just south of the intersection at Memory Lane (where the 2018 Road Program ended), and continues south to 13th Street. Within the project limits, there are two pipe crossings and the plans do specify the replacement of the existing pipes.

# NJDOT FY2018 Municipal Aid Project:

The construction work has been completed for the 2018 Road Program and the municipal building parking lot. The Contractor has submitted pay estimates for the work completed for payment.

# **Current Projects:**

# NJDOT - 2018 TAP Program - Folsom 13th Street Pedestrian Path Project

We will submit a proposal to the Borough for the costs associated with the construction management of the project since construction management was not funded by the grant.

### Planning Board Resolution #2019-8:

The Planning Board would like Council to consider amending Section 200-40.1 of the Borough Code to address the current technology for wireless communication and to preserve the rural character of the Borough.

# Review of the Ordinance changes, as updated by the Pinelands Commission on June 10, 2019:

In a discussion with the Pinelands Commission, they have offered some clarifications on the issues raised regarding the consistency of the ordinance and the Master Plan Re-examination Report. A rewording of the language in §200-17.1A(8) will allow for the single family dwellings existing at the time of the adoption of the ordinance, to be a permitted use and no other residential is permitted within the RDC zone. While the Pinelands Commission did review the Master Plan Re-examination Report and supported the creation of the new RCD zone, the Commission did not want to delay the adoption of the report, so it was suggested that the Borough move forward with the adoption of report and that revisions to the ordinances would be needed prior to ordinance adoption.

Mayor DeStefano inquired about the crooked striping of the Borough parking lot. Mayor Destefano asked for "No Parking Signs" across the back of the lot to prevent people from blocking the road and the entrance to the park.

# MAYOR'S REPORT: No report

#### **COUNCIL MEMBER'S REPORTS:**

**Councilman Greg Conway:** thanked John (DPW) and his crew on the loss control report survey conducted by the JIF. The report stated that the Borough has great housekeeping and safety training and there is no need for improvement. Greg reported that he attended a webinar regarding our Social Media policy and distributed to Council some changes he thinks would be good for the Borough.

**Councilman Ken Jantz**: stated he did not agree with the Parks Commission on the placement of the Veteran's Memorial. Ken asked residents to report any lights out to the Borough Hall or visit the Borough website.

Councilman Pagano: absent

**Councilman Arena:** updated Council on Parks & Rec.meeting. Councilman reported that the Parks Commission agreed to place the Veterans Memorial behind Borough Hall at right center field behind the fence. Charlie reported that the Community Garden has been cleaned up and thanked Jake Blazer for that.

Councilman Arena discussed the field lighting issue with the fall teams. Charlie stated that he feels the Borough should not be paying for lights for practice in the fall. They should be turned on for games only. Charlie encouraged anyone to come and discuss this issue with him.

**Councilman Hoffman:** reported that he received the quotes from the contractors to repair the plumbing in the restrooms. Councilman Hoffman requested approval to move forward with the quote from Bruce Bellace for \$6494.00. Councilman Hoffman made a motion to approve and seconded by Council Jantz. All in favor vote. Councilman Hoffman made a public announcement and asked residents to remove the portable basketball nets off the roadway and place back on your property. Jim asked the kids not to play in the streets.
