# 2012-60 A RESOLUTION AUTHORIZING CO-APPLICATION FOR DAM RESTORATION

**WHEREAS**, the Collings Lake Civic Association, Inc., desires to apply for a low interest State loan for rehabilitation of its dam spillway; and

WHEREAS, the improvement of the Lake Cushman and Lake Braddock dams will have a public safety benefit; and

**WHEREAS**, the Dam Safety Section of the New Jersey Department of Environmental Protection ("NJDEP") requires that applications for Dam Restoration and Inland Waters Loans be endorsed by a municipal co-applicant and be accompanied by a written resolution or ordinance authorizing a municipal official to sign the necessary application forms; and

**WHEREAS**, the NJDEP form, which must be signed is known as the "Application for Dam Restoration Loans", (a copy of which is attached hereto) and said form is reviewed by NJDEP for acceptability of the Project; and

**WHEREAS**, the Borough Council of the Borough of Folsom believes based upon the information available to date, that public safety would be advanced by the Borough acting as a municipal co-applicant.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Folsom, in the

County of Atlantic and State of New Jersey that:

- 1. The Borough Acting Clerk and Mayor are hereby authorized to sign the necessary papers and forms, including the attached application for Dam Restoration Loans as co-applicant with the Collings Lake Civic Associations, Inc.

- 3.
