**AN ORDINANCE ESTABLISHING AND FIXING SALARIES FOR VARIOUS
OFFICIALS AND EMPLOYEES OF THE BOROUGH OF FOLSOM, COUNTY OF

Be it ordained by the Mayor and Council of the Borough of Folsom, County of Atlantic, State of New Jersey, as follows:

ORDINANCE 02-2015**

**CALENDAR YEAR 2015
AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS
AND TO ESTABLISH A CAP BANK
(N.J.S.A. 40A: 4-45.14)**

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 1.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Borough Council of the Borough of Folsom in the County of Atlantic finds it advisable and necessary to increase its CY 2015 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Borough Council hereby determines that a 3.5 % increase in the budget for said year, amounting to \$18,921.00 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Borough Council hereby determines that any amount authorized herein above that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of Folsom, in the County of Atlantic, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2014 budget year, the final appropriations of the Borough of Folsom shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$1,026,261, and that the CY 2015 municipal budget for the Borough of Folsom be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

**AN ORDINANCE AMENDING CHAPTER 155 RECYCLING ARTICLE 1:
RECYCLING PROGRAM SECTION 155-3, ESTABLISHMENT OF MANDATORY
SEPARATION PROGRAM**

WHEREAS, the Council of the Borough of Folsom (Folsom) seeks to amend and revise certain provisions of the code of the Borough of Folsom pertaining to the list of recyclable materials which must be removed from the municipal solid waste stream by all persons within the Borough of Folsom as such have been designated within the Atlantic County District Solid Waste Management Plan to be source separated for the purpose of recycling; and

NOW THEREFORE, BE IT ORDAINED AND ENACTED, by the Council of the Borough of Folsom that the following provisions of the code of Borough of Folsom, County of Atlantic, State of New Jersey, is hereby amended as follows:

Section I: Chapter 155, Article 1, Recycling Program, Section 155-3, Establishment of Mandatory Separation Program should be amended to read as follows:

Section 155 – 3 Establishment of Mandatory Separation Program

There is hereby established a program for the mandatory separation of the following recyclable materials from the municipal solid waste stream by all persons within the Borough of Folsom.

- A. Aluminum can
- B. Ferrous containers
- C. Glass containers
- D. Newspapers
- E. Leaves, grass and brush
- F. Plastic bottles and jugs imprinted with a “1” or “2”
- G. White goods

- H. Asphalt and concrete
- I. Propane tanks
- J. Consumer electronics
- K. Motor oil, kerosene and number 2 home heating oil
- L. Antifreeze
- M. Sealed lead acid (SLA batteries)
- N. Consumer rechargeable batteries
- O. Tires
- P. Paper products
- Q. Aerosol containers
- R. Auto/truck bodies
- S. Block/brick
- T. CFC refrigerants
- U. Florescent bulb
- V. Oil-contaminated soil
- W. Oil filters
- X. Textiles

AND BE IT FURTHER ORDAINED all Ordinances and parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistencies,

AND BE IT FURTHER ORDAINED Should any sentence, clause, phrase or provision of this ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this ordinance.

AND BE IT FURTHER ORDAINED this Ordinance shall take effect upon its final passage, publication and adoption in the manner prescribed by law.

A RESOLUTION APPROVING THE FILING OF THE 2014 RECYCLING TONNAGE GRANT

WHEREAS, The Mandatory Separation and Recycling Act, P.L.1987, c.102, has established a recycling fund from which tonnage grant may be made to municipalities in order to encourage local source separation and recycling programs; and

WHEREAS, It is the intent and the spirit of the Mandatory Source Separation and Recycling Act to use the tonnage grants to develop new municipal recycling programs and to continue to expand existing programs; and

WHEREAS, The New Jersey Department of Environmental Protection had promulgated recycling regulations to implement the Mandatory Source Separation and Recycling Act; and

WHEREAS, The recycling regulations impose on municipalities certain requirements as a condition for applying for tonnage grants, including but not limited to, making and keeping accurate, verifiable records of materials collected and claimed by the municipality; and

WHEREAS, A resolution authorizing this municipality to apply for such tonnage grants (for calendar year 2014) will memorialize the commitment of this municipality to recycling and to indicate the assent of the Borough of Folsom to the efforts undertaken by the municipality and the requirements contained in the Recycling Act and recycling regulation; and

WHEREAS, Such a resolution should designate the individual authorized to ensure the application is properly completed and timely filed.

NOW THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Folsom, County of Atlantic, hereby endorses the submission of the recycling tonnage grant application to the New Jersey Department of Environmental Protection and designates John LaPollo to ensure that the application is properly filed; and

BE IT FURTHER RESOLVED that the monies received from the recycling tonnage grant be deposited in a dedicated recycling trust fund to be used solely for the purposes of recycling.

**SELF EXAMINATION OF BUDGET RESOLUTION
(as required by DCA)**

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Borough of Folsom has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the local government meets the necessary conditions to participate in the program for the 2015 budget year.

NOW, THEREFORE BE IT RESOLVED by the governing body of the Borough of Folsom that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has meet the following requirements:

1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:

- a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes
2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A: 4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
 3. That the budget is in such form, arrangement, and content as required by the local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated
 - b. Items of appropriation are properly set forth
 - c. In itemization, form arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
 5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
 6. That all other applicable statutory requirements have been fulfilled.

2014 Community Development Block Grant Funding

The funding for the improvement of several walkways at the 13th Street recreation complex, public works facility and South River Drive Park has been approved. The Borough should be receiving the agreement document within the next week.

NJDOT Route 54 / 322

As we requested, the signage alerting motorists that Bell Liquor Store is open are up. The DOT Resident Engineer has indicated he still expects that the portion of the work over Route 322 will be completed in May.

FY13 State Aid Project – 14th Street

The closeout documents have been prepared and forwarded to the Borough CFO for completion. Upon completion we will be forwarding them on to the DOT to finalize and receive the remaining 25% of the project funding.

Councilman Jantz asked Gary what the status was for the speed limit on 14th Street. Gary stated that Vince Polistina has been researching the Borough ordinance for any conflicts and should have more details for next month.

MAYOR’S REPORT: Mayor DeStefano congratulated the Folsom School and Educational Foundation on another successful comedy night. Mayor also informed residents that the League of Municipalities is offering a \$1,000.00 Mayor’s scholarship. Any seniors interested in applying should contact their school.
