ORDINANCE 06-2012

AN ORDINANCE OF THE BOROUGH OF FOLSOM VACATING PORTIONS OF ROAD B AND ROAD C

WHEREAS, the Borough of Folsom has received a request for the vacation of portions of Road B and Road C; and

WHEREAS, the Borough has determined that it has no need for these portions of right of way; and

WHEREAS, N.J.S.A. 40:67-1 allows for the vacation of these portions of right of way of Road B and Road C.

NOW, THEREFORE, be it ordained by the Borough Council of the Borough of Folsom, Atlantic County, New Jersey that the Borough hereby vacates its interests in the portions of right of way of Road B and Road C described more fully in the descriptions attached hereto as Exhibit A and Exhibit B prepared by Thomas A. Prendergast, PLS, dated May 10, 2012, and such right of way interest in the property is hereby returned to the adjacent properties being identified as lot 1 of block 2805 on the tax map of the Borough of Folsom.

BE IT FURTHER ORDAINED that the vacation of the portions of Road B and Road C is subject to an express reservation and exception from vacation all rights and privileges, if any, possessed by public utilities as defined in N.J.S.A. 40A:2-13 and by any cable television company as defined in N.J.S.A. 40A:5A-1 et seq. to maintain, repair and replace their existing facilities in, adjacent to, over or under the road or any part thereof, being vacated.

BE IT FURTHER ORDAINED that the public interest in the vacated portions of Road B and Road C are released in favor of the owner of adjacent lot 1 of block 2805.

BE IT FURTHER ORDAINED that all Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

BE IT FURTHER ORDAINED if any provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to such provision and the remainder of this Ordinance shall be deemed valid and effective.

BE IT FURTHER ORDAINED that this ordinance shall take effect upon its passage and publication according to law.

NOTICE IS HEREBY GIVEN that the foregoing Ordinance was introduced and passed on the first reading at a regular meeting of the Borough Council of the Borough of Folsom, County of Atlantic and State of New Jersey held on the 13th day of June, 2012 and said

Ordinance will be further considered for final passage, and adoption at a public hearing to be held in the Borough of Folsom Municipal Building, 1700 12th Street, Folsom, New Jersey on the 11th day of July, 2012 at 7pm or as soon thereafter as the matter may be reached.

RESOLUTION 2012-48 BOROUGH OF FOLSOM

A RESOLUTION ACCEPTING THE 2011 MUNICIPAL AUDIT

WHEREAS, N.J.S.A. 40A: 5-4 requires the Governing Body of every unit to have made an annual audit of its books, accounts and financial transactions, and

WHEREAS, the Annual Report of Audit for the year 2011 has been filed by a Registered Municipal Accountant with the Municipal Clerk as per the requirements of N.J.S.A. 40A: 5-6, and a copy has been received by each member of the governing body, and

WHEREAS, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs, and

WHEREAS, the Local Finance Board has promulgated <u>N.J.A.C.</u> 5:30-6.5, a regulation requiring that the governing body of each municipality shall, by resolution, certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled "Comments and Recommendations; and

WHEREAS, the members of the governing body have personally reviewed, as a minimum, the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations, as evidenced by the group affidavit form of the governing body attached hereto; and

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52 to with:

R.S. 52: 27BB-52: "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

NOW THEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Folsom, hereby states that it has complied with N.J.A.C. 5:30-6.5 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

RESOLUTION #2012-50

BOROUGH OF FOLSOM STATE OF NEW JERSEY COUNTY OF ATLANTIC

RESOLUTION APPROVING THE SALE OF LOT 13 OF BLOCK 2103

WHEREAS, the property known as Lot 13 of Block 2103 is owned by the Borough of Folsom and was offered for sale pursuant to the Local Land and Buildings Law, <u>N.J.S.A.</u> 40A:12-1 et seq., to the highest bidder from among the owners of real property contiguous to the property being sold; and

WHEREAS, title had become vested in the Borough of Folsom by the foreclosure of a Tax Sale Certificate for the property; and

WHEREAS, the foreclosure of the Tax Sale Certificate was financed by an escrow in the amount of \$2,000.00 posted by William H. Davis, III, representing an estimate of the fees and costs required to foreclose the Tax Sale Certificate; and

WHEREAS, the Folsom Council enacted Ordinance 01-2012 authorizing the sale of such land for a price of \$5,200.22; and

WHEREAS, the intent of the Borough Council was that the property be sold for the assessed value of \$3,600.00 and that an additional amount be added to the minimum price in order to recover and reimburse William H. Davis, III, for the cost of the foreclosure in the event that someone else purchased the property and, therefore, the minimum price of \$5,200.22 consisted of the assessed value of \$3,600.00 and the amount expended from the escrow for the tax sale foreclosure in the amount of \$1,600.22; and

WHEREAS, the only bidder for said property was William H. Davis, III, who bid the minimum price of \$5,200.22; and

WHEREAS, since the property is being sold to William H. Davis, III, who posted the escrow in the amount of \$1,600.22 the actual price to be paid by him is to be reduced by the amount advanced by him to pay the expense of the tax sale foreclosure; and

WHEREAS, since the cost of the tax sale foreclosure is a cost which was necessarily incurred in order to vest title to said property in the Borough of Folsom, it is also appropriate that such cost be shared equally between the Borough and William H. Davis, III.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Folsom, in the County of Atlantic and State of New Jersey that:

- 1) The sale of Lot 13 of Block 2103 to William H. Davis, III, as the sole contiguous owner offering a bid at the minimum bid amount is hereby approved subject to the adjustments set forth herein.
- 2) William H. Davis, III, is entitled to receive a credit in the amount of \$1,600.22 against the sales price of \$5,200.22, since \$1,600.22 represents funds actually advanced by him.

- 3) In addition, ordinarily such a tax sale foreclosure would have been undertaken by the Borough at the Borough's own expense, but here William H. Davis, III, advanced the funds to undertake the foreclosure and thereby allow the sale to take place for the mutual benefit of him and the Borough. Such foreclosure cost is appropriately shared as a common expense between the Borough and William H. Davis, III. Accordingly, the sales price of \$5,200.22 is also subject to a further credit to William H. Davis, III, in the amount of \$800.11. Therefore, the net price to be paid by him is reduced to \$2,799.89. William H. Davis, III, shall pay to the Borough the net purchase price of \$2,799.89, together with the cost of preparation of the deed of conveyance, related documents, and any other conveyance and recording costs for the transfer of title, by certified check, bank check or money order made payable to the Borough of Folsom.
- 4) Upon the completion of the transaction and the reimbursement of conveyancing and recording costs to the Borough, any remaining balance in the escrow account shall be released and returned to William H. Davis, III.

RESOLUTION 2012-51 **BOROUGH OF FOLSOM**

A RESOLUTION TO ENTER INTO AN INTERLOCAL SERVICE AGREEMENT WITH THE ATLANTIC COUNTY IMPROVEMENT AUTHORITY

WHEREAS, Atlantic County was notified by letter dated October 27, 2000, from the United States Department of Housing and Urban Development (hereafter HUD")announcing that the County of Atlantic qualified to receive a Formula Allocation for the Community Development Block Grant Program (hereafter the "Urban County Program") for the fiscal year 2001, 2002, and 2003; and

WHEREAS, it is necessary to provide documentation to HUD every three years to requalify the Urban County (hereafter"County") to continue to receive a formula allocation for the next three federal fiscal years; and

WHEREAS, it is necessary for the County to submit the qualifying documentation to HUD by June 30, 2012 to re-qualify for Fiscal Years 2013, 2014, and 2015;and

WHEREAS, in order to participate with the County in the Urban County Program for these years it is necessary for the Local Government to enter into a Cooperation Agreement with the County and other local governments; and

WHEREAS, the Local Government may not apply for grants or appropriations under the Small Cities or State CDBG Programs for the fiscal years during the period in which it participates in the Urban County CDBG Program, and

WHEREAS, Folsom Borough desires to join with the County in the Urban County program; and

WHEREAS, the Interlocal Services Act NJSA 40:8A-1 et seq. Authorizes counties and municipalities to enter into agreements for the provision of joint services; and

WHEREAS, the execution of the Cooperation Agreement does not require the Local Government to expend municipal funds;

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of Folsom as follows:

- 1. The Mayor and Clerk are hereby authorized and directed to execute the attached Cooperation Agreement with the County, and other local governments, in substantially the following form with such minor changes as may be required by HUD.
- 2. This Cooperation Agreement shall be effective for the remaining year of the Urban County Qualification period (Federal fiscal years beginning October 1, 2012, October 1, 2013 and October 1, 2014) and shall be automatically renewed for participation in successive three year qualification periods unless the County or the Borough of Folsom provides written notice it elects not to participate for a new qualification period.
- 3. HUD requires that this Cooperation Agreement may have to be amended to incorporate changes necessary to comply with federal requirements for future qualification periods. Failure to comply will void the automatic renewal for such qualification period.
- 4. All resolution or parts of resolutions inconsistent with this Resolution are hereby repealed to the extent of their inconsistency.
- 5. The Clerk is hereby directed to provide a certified copy of this Resolution together with the annexed Cooperation Agreement, duly executed, to the County executive.
