- 3. Office hours available to the Public shall be on Monday, 5:00PM to 7:00PM
- 4. Additional hours as required for attendance at Municipal Court and

IT IS FURTHER RESOLVED that compensation for Frank Sacco shall be based on an annual salary of \$6,525.00. Said wage shall be separately set forth in the Municipal Salary Ordinance as required by NJSA 40A:9-140.10.
